Seasonal Court Time

Community Sports and Wellness is now offering CSW tennis package members an opportunity to book seasonal court time for 2021-2022. The season will begin in September, the week of Labor Day, and end the week prior to Memorial Day, in May. It will exclude the two weeks during the Christmas/New Year’s holiday season.

All members participating in Seasonal Court Time (SCT) must be in good standing with the club and maintain a membership with the tennis package add-on. No guests or members without the tennis package can join a Seasonal Court.

Each seasonal court should have a court captain to handle the logistics of the court, including determining the weekly rosters and collecting payment from seasonal members. The captain will submit a single payment to CSW for the full amount of the court by the CSW registration deadline. If a “sub” is needed as an emergency fill-in they must be a member of CSW or pay a guest fee of \$15.

Applications for a SCT will be granted on a first-come, first-serve basis. Applications will be accepted via mail, email to jbrewer@communitysw.com, or via in person drop-off. CSW reserves the right to decline the application if the request interferes with currently scheduled programming. CSW also reserves the right to reschedule the SCT in the event of a building closure or special event. No refunds will be granted for missed days, but court time will be rescheduled. SCT that falls on holidays will be added to the end of the schedule.

SCT applications can be submitted between April 1 and April 16 for the indoor season. Applications will then be reviewed and finalized by April 20. If your application is accepted and you are granted the SCT, the full balance of your SCT will be due on May 7. If the balance is not paid by May 7, the court may be offered to another party.

The dates for the 2021-2022 season are September 6, 2021 through May 29, 2022 with two weeks off from December 20, 2021 – January 2, 2022. If SCT falls on a holiday the missed day will be added to the end of the schedule.

If a "sub" is needed for a seasonal court, the sub must either be member of Community Sports & Wellness or will be subject to the \$15 guest fee. Guests are only allowed to sub for a Seasonal Court Time and cannot be on the SCT roster.</p> <p>Applications for Seasonal Court Time will be granted on a first-come, first-serve basis. CSW reserves the right to decline your application if your request interferes with currently scheduled programming. CSW also reserves the right to reschedule your Seasonal Court Time in the event of a building closure or other special event.
